1. MASC/MASS Joint Conference 2021: Matt Hunt reminded everyone of the upcoming MASC/MASS Conference on November 3-6, 2021. Timalyn Rassias will be attending this conference.

#### **PRESENTATION**

1. NWEA MAP Presentation: Director of Teaching and Learning, Elizabeth Steele gave a presentation on the NWEA MAP Growth Assessments for the 2020-2021 school year.

#### What are MAP Growth Assessments?

- "MAP® Growth<sup>TM</sup> measures what students know and informs what they're ready to learn next."
- Dynamically adjusts to student responses
- To create a personalized assessment
- To measure performance accurately
- K-12 interim assessments  $\rightarrow$  3 time a year (fall, winter, spring)
- Web-based, computer-adaptive
- Grade level independent
- Multiple-choice, drag and drop and other types of questions
- Aligned to State Learning Standards

#### How are MAP Growth assessments scored?

- MAP Growth assessments measure student achievement and growth using the RIT scale.
- RIT stands for Rasch UnIT.
- The RIT scale is an equal interval scale like feet and inches on a ruler.
- RIT scores range from about 100-300

#### How has the pandemic impacted MAP Growth?

We were not able to perform 2019-2020 Spring assessments and the Littleton students had a little less growth than usual due to the pandemic. But in all grades we observed growth in comparison to the 2020 National Norms.

#### What do the reports and data say?

All students scored above the National norm

#### What are highlights/takeaways of the 2020-2021 MAP Growth assessments?

- MAP Growth Assessments are momentary snapshots that provide current data/information to pinpoint instructional areas that individual students are ready for, whether they are on, above or below grade level. Last year's MAP data shows that our students did make learning gains.
- We are meeting students where they are.
- Each grade/individual student will have varying areas and levels of strengths and improvements.
- Our students and educators have worked hard since the start of the pandemic to ensure all students have access to make educational progress and supports to do so
- Brad Austin This was a really helpful presentation. I appreciate all the work that students and staff did, and it shows with these results.
- Elizabeth Steele Yes, this is just one of the data points we use throughout the school year to plan instruction.
- Justin McCarthy It is not uncommon that our students tap out at the top. Are we using Standard deviation? Does it show data down to the individual student?

Elizabeth Steele – Yes, we use standard deviation. Yes, we get individual student data which is being used by the classroom teacher in order to identify if any support is needed for an individual student.

Jen Gold – It would be helpful if we track this data over the next semester.

Elizabeth Steele – We do keep an eye on the scores, but it is hard to report on the entire growth until we have completed all three assessments throughout the whole school year.

"A Multi-Tiered Systems of Support (MTSS) is a framework for how school districts can build the necessary systems to ensure that each and every student receives a high-quality educational experience. It is designed to support schools with proactively identifying and addressing the strengths and needs of all students by optimizing data-driven decision-making, progress monitoring, and the use of evidence-based supports and strategies with increasing intensity to sustain student growth." MA DESE

According to Every Student Succeeds Act (ESSA, 2015), a multi-tiered system of support is "a comprehensive continuum of evidence-based, systemic practices to support a rapid response to students' needs, with regular observation to facilitate data-based instructional decision making."

Harlacher et al. (2014) described six key tenets of the MTSS framework:

All students are capable of grade-level learning with adequate support.

MTSS is rooted in proactivity and prevention.

The system utilizes evidence-based practices.

Decisions and procedures are driven by school and student data.

The degree of support given to students is based on their needs.

Implementation occurs school-wide and requires stakeholder collaboration.

#### What does that really mean?

Allows all students and educators to be effective and successful academically, behaviorally, and social-emotionally

Allows schools to prepare all students to be college / career / future ready while eliminating barriers in a system that prevent all students from being really successful

Proactive to address the barriers that may prevent all students from being able to learn

Supports moving away from a one-size-fits-all to one that is based on the principles of UDL (Universal Design for Learning)

Brad Austin – Is there a toolkit for each Tier?

Elizabeth Steele – It is more fluid than that. An example of a support at tier 2 that some families may be aware of is the Title I program. This is fluid throughout the year.

Justin McCarthy – This was very helpful. What raised the question for this presentation was because of the \$150,000 which has been set aside for MTSS.

- 35 Elizabeth Steele – It is going to be used across the board for MTSS as a whole. We are bringing in an 36 expert to look at our support systems and where we could boost our support systems.
  - Kelly Clenchy We have given you a lot of information tonight. The MAP Assessment is just one data point. That along with individual teacher assessments helps the teacher to implement instruction strategies. We added in MTSS to prevent any student to be placed on an IEP if it isn't necessary. We are excited to bring in an expert to give our teachers more tools to their toolbox.
  - 3. Financial Update: Business Manager Steve Mark gave a brief overview of the Financial Statement and cost center descriptions for FY22. The spreadsheet(s) are included in the packet.
  - 4. SIP Presentations for Littleton Middle School and Littleton High School: Principal Jason Everhart and Principal John Harrington gave a presentation on their School Improvement Plans.

#### Steps ahead in the Process

- Develop a working group of stakeholders and gather input from community members, staff members, students, and alumni as well as specific Littleton groups (e.g., PTA, LEF, SEPAC, Athletic & Music Boosters, School Councils, and School Committee)
- Examine and possibly refine our core values, mission statement and beliefs about learning
- Review various portraits/visions of a graduate from other school districts
- Develop a plan for collecting stakeholder input/feedback via surveys such as google forms, survey monkey or thought exchange
- Develop a visual representation of the Vision of a Graduate
- Draft a Vision of a Graduate for review by School Leadership Team, School Council, Admin Council, faculty, staff, and student leaders
- Revise Draft after considering collected recommendations and feedback
- Present final version to School Committee for approval Financial Literacy at LHS
- As part of our Vision of a Graduate, LHS is planning to provide a financial literacy course/online module experience for each high school student before they graduate
- LHS has partnered with DCU (Everfi) and Main Street Bank (Banzai) to bring free online financial literacy programs to LHS Students
- LHS students have access to Financial Education Modules about financial decision-making, earning income, buying goods and services, saving, investing, retirement planning, budget management, using credit, etc. We need to further facilitate this experience and are considering making this part of a flex block activity this school year
- In addition, LHS added an AP Microeconomics course this school year. LHS has offered a semester Economics elective since 2015.

#### Financial Literacy Fair at LHS

- LHS began planning a Financial Literacy Fair in the Fall 2019 and scheduled it for April 15, 2020. This event was canceled due to school campus closure and Covid-19
- LHS is planning to schedule an in-person Financial Literacy Fair this school year. Date is TBD
- Littleton Education Fund previously allocated \$1050 grant for an LHS Financial Literacy Fair
- LHS also received a \$5000 Grant for a Financial Literacy Fair from the Financial Education Innovation Fund, MA Office of Economic Empowerment
- The National Financial Literacy Standards1 define the standards and benchmarks for the knowledge and skills that students should gain from a personal finance program. LHS will align its offerings with these standards

Brad Austin – I think using the Flex block the way it is presented is a great idea. Justin McCarthy – I think the Financial Fair is a great idea.

2. High School Vaccination Rates: Superintendent Clenchy gave an update on the High School Vaccination Rates to date. As of Sept. 30, 201 the High School vaccination rate is at 73% rate for the faculty. Student and

staff combined is at 54% at this point. Commissioner Riley has extended the mask mandate to Nov. 1, 2021.

Superintendent Kelly Clenchy asked the School Committee how they would suggest we handle the mask mandate. Are we going to look at transmission rate or only the vaccination status at the High School? That is something there will be discussed at the next meeting.

He also reminded the community to submit their child's vaccination status. Parents need to email their child's school nurse with a copy of the vaccination card or email the date(s) of vaccination. The school district has been granted access to a vaccination database where we can verify the information.
