Brad Austin – What is the laser cutter?

Michelle Kane – It is almost like a 3-D printer, but this is a machine that can cut out letters and other things in many different materials.

Justin McCarthy – Dyslexia screening? Have you done any screening yet?

Michelle Kane – It has been discussed a lot through DESE. But this year they have decided to implement it.

Elizabeth Steele – Aimsweb will do both Dyslexia screener and an Early Literacy screener. It will be used three times a year. We will participate in professional development next Wednesday, Oct. 20. But currently, we are still within the fall screening time frame. The screener will take around 20-30 minutes per screening in grades K through grade 2.

Justin McCarthy – Hopefully after you get through one or two screeners, I am hoping we will be able to get an update.

NEW BUSINESS

1. State/Local/Public Health Metrics: Katrina Wilcox Hagberg provided a presentation on the State/Local/Public Health Metrics. Her data presented was through October 14, 2021.

Test positivity rate is now at 4.53% in Littleton. Littleton's rate is 35.9 per 100K. Littleton had 49 new cases in the last two weeks.

75.2% of all Littleton residents are fully vaccinated at this point. 29 cases have been reported within the school district in the last two weeks. We have had our first positive testing pool within the schools.

Justin McCarthy – Would we be able to share information if cases in the different schools are family related. Lyn Snow – Because of confidentiality we cannot share that kind of information.

2. High School Vaccination Rates: Pupil Services Director Lyn Snow gave an update on the High School vaccination rates to date. As of Oct. 14, 2021 the High School vaccination rate is at 78.3% rate for the faculty. Students are at 60.3%. Student and staff combined is at 62.9% at this point.

Who administers the BinaxNOW tests and Routine COVID Safety Checks?

The BinaxNOW and routine COVID safety checks are administered at school by trained staff For staff and for students in grades Kindergarten and up, both tests may be conducted by self-administration and observed by trained staff.

For BinaxNOW tests, trained staff must process the test which means conducting the process of insert and turn the swab in the test card kit, close the card, and read and report the result. (Updated 10/7/21)

Are students and staff allowed to self-swab with the BinaxNOW rapid tests used for Symptomatic or **Test and Stay?**

Yes. Like routine COVID safety checks, staff and students in grades Kindergarten and up may selfadminister the swab while observed by trained staff.

Trained staff must conduct the test procedure itself (insert and turn the swab, close the card, and read and report the result)

(Updated 10/7/21)

What are the options if BinaxNOW tests for positive pool members are all negative?

All negative BinaxNOW tests likely indicate an individual of lower viral load that is less likely to be infectious. (see ref)

If this occurs, Littleton Public Schools will conduct a second BinaxNOW test on all individuals (no sooner than the next day, but within 2 days)

(New 9/22/21)

Littleton Public Schools current collection method:

Routine COVID Pooled Testing and Lab-Based Follow-Up Testing – two sample collections: two samples are collected at school, after which both specimens are transported to the laboratory; If a pool is positive, individual Follow-Up testing occurs at the lab using the second sample originally collected.

Samples are collected through a nasal swab

Samples must be collected at school. Students may collect through observed self-collection Samples are processed at the Broad Institute

A maximum of ten samples are included in each pool

Routine Pooled Testing and Lab-Based Follow-Up Testing: samples are collected; If a pool is positive, individual Follow-Up testing occurs at the lab, without a second sample collection

In this model, individual anterior nasal (AN) swab samples are placed into a single dry sample tube (no transport media) with a maximum of 10 swabs per tube. At the laboratory, highly automated processes are employed for accessioning, decapping, swab rehydration, sample transfer, RNA extraction, and target analyte detection.

In order for the program to be effective, four things must be in place:

short turnaround times for pooled test results;

- 2) pooled test capacity;
- 3) rapid reflex testing; and
- 4) a robust result reporting system.

LIMITATIONS

DELAYS

CIC's lab partners are currently experiencing unprecedented volume, causing a delay in the time that results will be made available. At this time, we have been told to expect that results may be received between 36-48 hours from the time of testing.

LPS has had to conduct reflex testing

ALTERNATIVE OPTION (Veritas)

single nose swab, which then goes through deconvolution in the lab for any positive pools.

Turnaround time is 24 hours from receipt of samples at the lab, +3 hours for any deconvolution result to identify the diagnostic positive.

COVID-19 Symptom Checklist

Presenting with any of the following symptoms?

- Fever (100.0° Fahrenheit or higher), chills, or shaking chills
- Difficulty breathing or shortness of breath
- New loss of taste or smell
- Muscle aches or body aches Cough (not due to other known cause, such as chronic cough)
- Sore throat, when in combination with other symptoms
- Nausea, vomiting, or diarrhea when in combination with other symptoms
- Headache when in combination with other symptoms
- Fatigue, when in combination with other symptoms
- Nasal congestion or runny nose (not due to other known causes, such as allergies) when in combination with other symptoms

Vaccinated individuals should only answer "yes" if experiencing symptoms in bold Unvaccinated individuals should answer "yes" if experiencing any ONE symptom in bold and/or any combination of symptoms not in bold

The school nurse may use his/her discretion as to whether a student should be attending school. The school nurse will contact the parent/guardian to discuss the student's health related illness.

SYMPTOMATIC STUDENTS

Any student who exhibits symptoms as per the district sick policy should remain at home.

If students exhibit symptoms consistent with being at risk for COVID-19 and have consented to participate in the district COVID-19 testing program, we will administer a BinaxNow rapid test.

Symptomatic testing is used when a student is showing symptoms of COVID-19 during school. Some symptoms of the virus look identical to other illnesses like the cold or flu, and the BinaxNow test tells us whether a symptomatic student has COVID-19 or not.

Regardless of the results, you will be contacted to pick your child up so that your child may recuperate from their illness at home.

Please refer to the District Health Protocols for school attendance and the COVID-19 Symptom Checklist.

The school nurse may use his/her discretion as to whether a student should be attending school. The school nurse will contact the parent/guardian to discuss the student's health related illness.

'MILD' SYMPTOMS

The Protocols for Responding to COVID-19 scenarios refers to mild symptoms. What symptoms are considered mild?

Mild symptoms: This refers to any single (isolated) symptom on the list below if the symptom is also mild. If a symptom is severe (based on the clinical judgement of school health professionals), even if isolated, then it should not be considered a mild symptom.

- Cough
- Sore throat
- Nausea, vomiting, or diarrhea
- Headache
- Fatigue

- Nasal congestion or runny nose (not due to other known causes, such as allergies)

PLEASE NOTE:

The school nurse may use his/her discretion as to whether a student should be attending school. The school nurse will contact the parent/guardian to discuss the student's health related illness.

The pool testing continues to go well. The staff who is doing the pool testing are very friendly and organized. As of today's date, participation rate is as follow:

SL 50% students – Staff 63%

RSS 64% students – Staff 58%

LM 56% students - Staff 34%

LHS 45% students - Staff 55%

Justin McCarthy – How does this compare to other towns?

Lyn Snow – We are doing a great job with our pool testing program early on. I think it is so helpful that we are able to catch an asymptomatic student or staff before they spread to other people.

Jen Gold – If you enroll in the test & stay you are consenting your child to participate in all three programs. Brad Austin – We are only looking at 53% of the total school population. I am just encouraging everyone in our community to sign up for the pool testing program to help everyone to stay safe.

Lyn Snow - I am positively optimistic that more people will sign up for the program now that parents can see how the program is working. That their child can continue to be in school with the "test & stay" program.

INTERESTED CITIZENS

Erica Podgorni – You are encouraging people to submit their vaccination status and to sign up for the pool testing. Parents have the right to know what the factors are if they submit their child's vaccination status. In my district they also want the pool testing to reach 70% participation rate before they will lift the mask mandate.

Matthew Ridge – The FDA approved the Covid vaccine. Any vaccination will not get full approval until 2023. People are afraid to give out the information on their own child, when they do not know what will happen with the information. Will we have to wear masks forever in Littleton? When are we going to say enough is enough?

Sandra Santoro – My children are both in the preschool classroom that needed to be quarantined and they have not been in school since last Thursday and we did not find out until Tuesday that they had been in close contact, so I feel there was a significant delay. I feel this board is more focused on when we can lift the mask mandate than protecting our children.

Kelly Clenchy – Our safety check program is helping as time goes on.

Jen Gold – We all want as many to opt in as possible.

Justin McCarthy – Please share your ideas on how to increase the numbers in pool testing. If you are not doing it for yourself, do it for your child's teacher.

Greg Tesz – Pool testing. The number needs to be higher. Turning in the vaccination status. I do believe that you should share what you are intending to do with the data. Families might be sharing the information easier if you were more transparent.

Brad Austin – We do try to be as transparent as possible and follow the open meeting laws and this is the forum where we discuss this.

Matt Hunt – As we come along with more data, we will be sharing it and we are hoping to have a meeting 384 385 with the Board of Health before our next school committee meeting. 386 387 Lexie Yang – We need to see more people participating in the pool testing. + Pros to Flex Block Schedule

- Fewer classes per day
- Longer class blocks
- 25 minute lunch
- Rotation of Classes
- Helps to address student stress / workload concerns
- Enhances Advisory Program
- Close to 30 additional hours of Time on Learning
- Daily Flex block provides:
 - Built-in structure for Advisory activities, Class meetings, etc...
 - Equitable opportunities for all students to access support
 - Expanded opportunity for Direct Service providers to access students...without taking students out of class
 - Opportunity to strengthen connections between students and staff

⁺ Anticipated Challenges and Solutions

- Different length classes may cause challenge in planning
 - Tried to schedule classes with multiple sections in same length class
- Not having every mod meet may present challenges in guaranteeing daily teacher prep period
 - Intentional scheduling of teacher prep time (ex. Have both A and B off
 or Neither A nor B off)
 - Shared teacher duty responsibilities
- Don't see classes every day; students need daily practice or more attention
 - Student can be scheduled into extra help sessions during flex
- Students sitting in classes for long periods of time in masks
 - Continued mask breaks

How it's going...

- General feedback indicates that staff and students like the new schedule
 - Early confusion has dissipated
 - Advisory activities geared to adjusting to new rotation
 - Less frenetic pace to the school day
 - Students reporting less academic stress
- Class meetings and Activities without disrupting classes
 - Elections
 - Academic Awards
 - ALICE, Cybersafety (upcoming)
- Students are generally self-selecting Flex Block activities
 - Extra Help, Club Meetings, Unstructured time

- Continued support through PD for teaching in the longer block
- Develop consistency among staff and students using Enriching Students
- Use Grade Data to help inform Flex Block appointments
 - Targeted Interventions
- Schedule surveys to collect feedback

- Allow opportunity for staff and students to develop Flex Block learning opportunities
