#### **RECOGNITION**

- **1. Student Representative(s) Update:** Student representative, Stella Austin gave an update on upcoming school activities and events taking place at all four schools.
- **2. Rotary Thanksgiving Day Breakfast:** Superintendent Kelly Clenchy recognized the Rotary Club for sponsoring the Thanksgiving Day Breakfast. All proceeds go to the Littleton Scholarship Trust. A shout out to the 10 Students from the High School who volunteered their time and were a tremendous help.
- **3.** The Town of Littleton and Littleton Public Schools hosted their second vaccination clinic on November 29th. The clinic was held inside at the middle school. Dr. Clenchy thanked everyone who has been involved with this initiative. Two more smaller clinics will take place in January 2022.

#### **NEW BUSINESS**

- 1. State/Local/Public Health Metrics: Matt Hunt provided a presentation on the State/Local/Public Health Metrics. The data presented was through December 1, 2021.
  - Test positivity rate is now at 5.29% in Littleton. Littleton's rate 38.1 is per 100K. Littleton had 52 new cases in the last two weeks.
  - 79.2% of all Littleton residents are fully vaccinated at this point. Littleton Public Schools reported 7 cases this week.

2. LHS Attestation approval from the Department of Elementary and Secondary Education-attached letter: Superintendent Kelly Clenchy discussed the approval of the LHS attestation form indicating that the high school has reached the required 80% vaccination rate. The approval letter from Commissioner Riley's office was included in the packet.

Brad Austin – What is the number of participants in the pool testing at the high school? John Harrington – I do not have the exact number of participants, but the number is increasing. But the mask flexibility is differently an incentive.

- Justin McCarthy What is the number for the middle school, as more students have been vaccinated at this point?
- Kelly Clenchy This is something we are looking at and will discuss further at a later meeting.
- Matt Hunt We might be getting pretty close to an 80% rate at this time.
- Kelly Clenchy We will be able to provide a more accurate number at the next meeting.

Matt Hunt – Superintendent Clenchy and I met with the Board of Health yesterday. We originally were thinking we could start the mask flexibility on Dec. 6, but BOH was not ready to move forward. We asked that they vote on the exemption at their next meeting scheduled for Dec. 15, 2021, for a start after the holiday.

Matt Hunt mentioned that he is not sure how he feels about the "Mandatory Active pooled testing participation for those that choose to participate in all optional extracurricular activities". He feels that it could be removed from the exemption.

#### **Conditions for Trial Mask Exemption**

- Mask exemption will be for a three-week trial period
- Proof of vaccination required
- Parental consent required
- 100% Active pooled testing participation for those that choose mask flexibility participants identified with a wrist band as visible identification post weekly testing prior to removing mask.
- Mandatory Active pooled testing participation for those that choose to participate in all optional extracurricular activities
- All students and staff choosing mask flexibility shall be tested prior to the start of the three-week trial period to establish a baseline of case count
- Should the weekly case count double for two consecutive weeks, masks will again be required
- The Littleton Board of Health may at any time rescind the exemption should it determine there is substantial public health risk.
- All other mitigation measures remain in operation

Brad Austin – I appreciate the work done on the trial mask exemption. I would like to know what our threshold number will be. Do we have an idea how many students outside of the winter sports are taking part in extracurricular activities?

 Kelly Clenchy – When you look at percentages, I looked at 2-2.5% as a number. That means 10 students. If we have more than 10 students, we might want to require that the mask goes back on again.

Justin McCarthy-I do agree we need some sort of number to monitor but I encourage that we concentrate on contact tracing and close contact instead of a specific number.

Matt Hunt – Board of Health is looking at a January 18, 2022, start date so if students or staff who are not vaccinated at this point are interested in participating in the mask flexibility, then they will have a chance to get their vaccine shot before the start date.

Kelly Clenchy – I do believe a number will be well-served to monitor this program. I do believe this will be our best way to catch anything.

Matt Hunt – I am fine using a number for monitoring.

Justin McCarthy – Let me understand the number. If the number of cases increase above 10 cases, then mask goes back on immediately.

Brad Austin – What do you think of the two-week period with the masks on again?

Kelly Clenchy – It depends on what people are comfortable with. But I do have concerns with the wristband as identification. We need to trust our students, that's one of our core values.

Brad Austin – I am not comfortable with the mandated active pool testing for extracurricular activities. I think that needs to be removed from the motion

Matt Hunt – I think the teachers all know the kids and it might be easier to identify another way.

John Harrington – I do think this is an operational piece of it that the school can handle. We do have reservations having the students wear a wristband. It is not summertime, so most students are wearing long shelves. We could be monitoring it through a google doc with all names of students who participated in the pool test and if they missed it one week, they would be ineligible for that week to participate in the mask flexibility program but continue the following week if they got pool tested again. I believe we will be able to find an easy way to verify the pool testing status.

Kelly Clenchy – We have worked hard in this district to ensure our students know we are very proud of them and that we are educating the whole child.

Brad Austin – Maybe you can find a way to verify it through the students' phone?

Kelly Clenchy – We might be able to use a QR code?

 John Harrington – There are ways to verify. We will be discussing with the students' what options they find are best.

4. Littleton Board of Health's response to request for a Waiver. Superintendent Kelly Clenchy and School Committee members discussed the response from the BOH regarding a request for a waiver from the town-wide indoor mask mandate specific to LHS, which would permit the School Committee and Administration to consider the implementation of a three-week trial which would permit vaccinated staff and students to exercise mask flexibility. (Potential Motion)

- On a motion by Matt Hunt and seconded by Timalyn Rassias it was voted to approve the trial period from 134 Jan. 18, 2022 – Feb. 4, 2022 and send a notice to the BOH indicating the request for a waiver from the 135 Town wide mandate during the new trial period providing the town-wide mask mandate remains in effect 136 137
  - beyond January 15, 2022. (AYE: Unanimous). Motion carried.
- Roll Call Vote: Matthew Hunt, AYE; Brad Austin, AYE; Justin McCarthy, AYE; and Timalyn Rassias, 138 139 AYE.
  - On a motion by Justin McCarthy and seconded by Brad Austin it was voted to approve the conditions for the trial mask exemption as follow:
  - Mask exemption will be for a three-week trial period, Proof of vaccination is required, Parental consent required for students under 18 years old, 100% active pooled testing participation for those that choose mask flexibility – participants will be identified by the administration as determined and results will be posted weekly prior to removing mask. All students and staff choosing mask flexibility shall be tested prior to the start of the three-week trial period to establish a baseline of case count. Should the weekly case count be more than 10 positive cases then masks will again be required, The Littleton Board of Health may at any time rescind the exemption should it determine there is substantial public health risk. All other mitigation measures remain in operation. (AYE: Unanimous). Motion carried. Roll Call Vote: Matthew Hunt, AYE; Brad Austin, AYE; Justin McCarthy, AYE; and Timalyn Rassias, AYE.

Participant verification will occur through the Aspen Student Portal and student compliance will be handled through already established routines and procedures that have been implemented within the school.



In consultation with the school district's lawyer, the wearing of wrist bands would be considered self- identifying. The use of an established data base for verification would make it difficult in establishing a standard of bearing- a rational relationship to a legitimate state interest. Our district PPS Director agrees with the self- identifying nature of wearing wrist bands as a means of verifying compliance and has further concerns that it could rise to the level of overt discrimination via unnecessary labelling of student differences.

The High School administration will work with staff and consult with students to establish procedures to maximize compliance in this area. Every teacher has access to our Aspen portal which is utilized throughout the day. As a district we have worked diligently to establish a culture of trust within our faculty and student body- to change our current approach would be contradictory to our current practice.





Mandatory Active pooled testing participation for those that choose to participate in all optional extracurricular activities

#### <u>Rationale</u>

The majority of extracurricular activities occur within the school building and as a result, students would be required to adhere to the mask flexibility criteria. We feel that most of our students in both extracurricular and athletic programs would opt in to the school district's mask flexibility program.

In terms of our athletic programs the MIAA (Massachusetts Interscholastic Athletic Association) sets protocols for our athletic programs throughout the State. Currently all indoor athletic programs are required to have their participants mask regardless of vaccination status until at least January 15, 2022. Our High School has a number of Co-op teams with other schools and as a result would have students from other school districts participating on these teams which would counterbalance the benefit of mandating participation in pooled testing.

With the proposed requirement, students that are legally mask exempt due to a medical condition or accommodation would not be able to take part in extracurricular and athletic programs. Both the School Committee and Administration would not feel comfortable restricting the opportunity for our students to participate in extracurricular and athletic programs as a result of a mandatory requirement to take part in the school's safety check program.

- All students and staff choosing mask flexibility shall be tested prior to the start of the three-week trial period to establish a baseline of case count
- Should the weekly case count double for two consecutive weeks, masks will again be required. During the trial period, mask flexibility will be permitted if the High School's weekly COVID-19 case rates are less than or equal to 10 cases. Eleven cases or more in a given week would require mask wearing until the weekly case rates dropped to the acceptable level to allow mask flexibility.

#### Rationale

The School Committee and Administration feel more comfortable with a numerical range that would either permit or restrict mask flexibility. A positive COVID case count within LHS of a maximum of 10 cases per week to allow mask flexibility represents approximately 2% of the school's population. With our past experience with positive COVID cases in our schools, we feel the 2% ceiling is conservative and with our current mitigation strategies would allow us to effectively mitigate the risk of further spread within our schools. If at some time we extend the opportunity for mask flexibility in our other schools the numerical range that we have chosen could be applied to these schools. Our community has advocated for data points in the past and as a result we feel that the range that we are recommending is in line with their desire to utilize tangible metrics for decision making.

**Recommended Motion:** Approve the establishment of a "capital reserve fund" in conformance

with the provisions of 603 CMR 50.07 (10).

#### **INFORMATION:**

As set forth in 603 CMR 50.07(10) Educational Collaboratives may establish a capital reserve fund. The purpose is to support costs associated with maintenance and improvement of fixed assets that the Collaborative is unable to accomplish out of the operating budget.

The Collaborative Board may use anticipated cumulative surplus to support a deposit to a capital reserve under the following conditions:

- Funds in a capital reserve account may be used only for the project or purpose for which the account was established.
- The establishment of a capital reserve shall be subject to the approval of 2/3 of the member districts. The request for approval must state the reason for the reserve and a limit on the balance that may be held in the reserve. (see Capital Plan)
- Deposits into and withdrawals from the capital reserve shall be proposed and approved through the Collaborative budget process.
- In the event that the purpose for which the capital reserve was created requires modification, the collaborative board of directors shall revise its capital plan and provide notice to all member districts. If the member district does not vote to disapprove the revised capital plan within a 45 day period, that member shall be deemed to have approved the revised capital plan. Two-thirds (2/3) approval of the member districts is required to revise the capital plan.

#### **INFORMATION:**

The Collaborative has a goal to provide equitable and accessible services to more students with varying disabilities. It is important especially for our population to have recreational space that all is accessible and inclusive.

The current floor and site plan at the Colebrook School does not have any large areas dedicated to physical education and creative social play. Based on a surge in referrals for elementary level students, classroom space is also a priority.

The Collaborative would like to propose two projects with that goal in mind. One to be funded this year and the other to be funded in the future.

Playground + Transportation Office Move Proposal: \$300,000 (19.5%)

Member District Transportation Assessment/Credits Remaining to be Applied: \$1,221,225.75

This project would also include moving the Transportation office to another location within the building. CASE would use the current transportation space of 1,550 sq ft to accommodate and adapt to special education services required by our member districts.

Providing students with access to facilities as those that are available to them in their home districts is a matter of equity and will allow CASE to serve students and our sending districts in a more equitable and appropriate manner.
