appreciation to staff and students for their effort in the pool testing. Michelle Kane – Thanked the Shaker Lane nurse, Mary Philpot for all the work she is doing with the pool testing and the preschool teachers for welcoming 3 new preschool students this past Monday into their classrooms.

#### **PRESENTATION**

**1. Update on HS Band Trip to Florida:** Request for HS band trip to Orlando, FL in February 2022: Music Teacher Hilary Bridge gave a brief presentation of the HS band trip to Orlando, FL in February 2022.

On a motion by Timalyn Rassias, and seconded by Matthew Hunt, it was voted to approve the High School trip to Orlando, FL in February 2022 as presented. (AYE: Unanimous). Motion carried. Roll Call Vote: Matthew Hunt, AYE; Brad Austin, AYE; Justin McCarthy, AYE; Timalyn Rassias, AYE; and Mike Fontanella, AYE.

- **2. State/Local/Public Health Metrics:** Katrina Wilcox Hagberg provided a presentation on the State/Local/Public Health Metrics. Her data presented was through Feb. 24, 2021.
- Test positive rate is now at 1,79% in Littleton. Littleton's rate is 14.6 per 100K. Littleton has 20 new cases.
- MA School data is at 373 students of in-person students and 209 staff members. Littleton Public Schools have had 38 cases total to date, which includes both hybrid and remote students.

"The best vaccine is the one you can get".

Matthew Hunt – Real positive information. We are not quite there yet but the trend is going the right way.

- Brad Austin Thank you for the presentation. Are you getting information from other schools on how they are doing with their pool testing? Are we able to hear from other districts in this area if they are having the same positive results?
- 62 Katrina Wilcox Hagberg I have not seen any data yet. It is not being reported out yet.
- Kelly Clenchy We have been asked by the provider not to report out at this time. The State will continue their free pool testing through April 18.
- Lyn Snow With part of mass communication, we must be cautious. If we had a positive pool testing, people would start to wonder if their child is in a classroom with a positive pool tester. But please consider
- participating whether you are a staff member or a student. The data is more meaningful with a higher
  - participation rate. We are now around 60% participants of both students and staff members. There will be a lot of networking with other districts as we move forward.

Justin McCarthy – Appreciate all the work you are doing. Appreciate your explanation of the clarification of why Littleton falls into the -10,000K population. But I think we should report the pool testing result out. Mike Fontanella – I think we must be careful on how we say this. If you do not hear anything back on your pool testing result, you can only assume it is because it was negative.

Lyn Snow – We have 24-48 hours to get the results back from the pool testing. If we do not get the results within that time frame, I would inform the participants that we have not gotten the results at that time.

**3. 2021 MCAS Testing:** Chair Mike Fontanella discussed with the School Committee the 2021 MCAS Testing. At this time several districts are thinking about contacting DESE to see if districts could push out MCAS testing or if DESE decides to have MCAS to change the way it is being used.

Kelly Clenchy – I have always supported and valued the MCAS testing but having the year we have had I am not certain about this year. But just so everyone knows, the Biden administration has already come out and said they would not provide any waivers this year for standardized tests. To receive federal funding, you have

to obey the regulations. But we have not gotten any guidance on how to run the exams for our fully remote students unless we ask them to come into the buildings. That is truly problematic.

Mike Fontanella – If a family is fully remote and does not want to send their student into the building to take the MCAS test, they can opt not to have their child take the test. But then the data becomes even more questionable in terms of value because it will not be as deep a survey of our student population than we would typically expect.

Elizabeth Steele – It is another data point which is good for our own use. But it is a tricky year to compare the data. In a typical year we would like to see a participation rate of at the very least 95%. If families choose not to test and we go below the 95% we do not know at this point how that will affect our accountability as a district.

Mike Fontanella – Are there any waivers for the sophomores for this year? So, the sophomores will be taking the ELA and Math MCAS tests this year.

Elizabeth Steele – Students in grade 9 will be taking the MCAS Science test. The current grade 10 and 11 students will not be taking the science MCAS test. But our sophomores will be taking the ELA & MATH MCAS exams, as well as our junior class.

Brad Austin – I am not a fan of standardized testing. Bringing students into the building, who normally is not in the building. What about the John & Abigail Adams Scholarship? How would that be affected? John Harrington – We are waiting to hear from DESE on any guidance.

Flizabeth Steele. The opportunities are still available for any scholarsh

Elizabeth Steele – The opportunities are still available for any scholarships but the calculation of the scores will be different than previous years.

Matthew Hunt – If a student is taking the test at home, I might be worried that the student could be cheating.

Justin McCarthy – I see the MCAS test as another valuable data point.

Timalyn Rassias – I agree with everyone.

Mike Fontanella – I do think it is worth to participating, but I hesitate to allow students to take the test at home, so we might want to contact DESE for some clarification on accountability. Matthew Hunt and Brad Austin will work with the administration on a letter to DESE.

Kelly Clenchy – Our first MCAS test is scheduled for April 5, 2021.

#### **Public Input:**

Jen Gold – Going back to the pool testing data. Why is the pool testing data not being counted into the overall data that is being reported from the state? I truly believe they should be counted to give us a true picture of the positive versus negative tests overall.

Lyn Snow – The pool testing is a screening tool. The reflex test would be counted into the state data.

Mike Fontanella – A lot of this we are already familiar with, but the big takeaway is how do we handle the space? If your district falls into the lower category you should be striving for 6-feet, but you should be willing to go below 6-feet if you can get the students back into the building. You really need to be looking at the community infection rate and not the infection rate in your school to determine what risk category you are in.

Justin McCarthy – Are you able to identify where we are on the CDC guidelines? We need to provide a safe learning environment for our students.

Katrina Wilcox Hagberg – I have looked into where we fall into the CDC guidelines, but we need to determine if we are using county level numbers or our own community numbers of the test positivity rate.

Timalyn Rassias – I know we have asked for the square footage of the classrooms. I need that before I can make a decision. I am looking to see how it is going to work when we have more students in the elementary schools next week.

Matthew Hunt – We really have to start seeing what we can do to get more students into the school.

Brad Austin – It seems that some of our own data is better data than the CDC data. We all want to have more students into the school.

Mike Fontanella – In the CDC report, they are not demanding how anyone wants to use this guidance. The 6-feet has served us well. But it would probably be good to look at the square footage. We will not be able to get all in if we use the 6-feet distance. We simply do not have the space for that with all the students in the building. I think this is a guidance. I am comfortable with the process we have started. I am looking for progress.

Brad Austin – It is very complicated. We have negotiated 6-feet so if we go to 3-feet we need to go back to negotiation.

Justin McCarthy – We could have started the school year full-time back in September. I feel like we need to open the schools back up, just like we had to close them down last March. We need to move forward and move fast. I feel very strongly that in the next couple of weeks we should be able to have all our K-5 students back in the schools otherwise we are cheating them out of in-person instruction learning.

Matthew Hunt – I do think we did the responsible thing when we started the school year to make sure we did not rush into something. I certainly do not regret any process we have gone through this year. I think we can get kids in more days this year. We have a plan, and we should strick with that.

Brad Austin – This debate is healthy. We want to have a plan to move forward if we get to a place where we can have more students in the building. Some of the things we decide to do we might need to re-negotiate.

Mike Fontanella – We use the data to inform us. I want to make sure we do not make a rash decision along the way. The trends are good, but the numbers are not where they were in September and October. Do we know that this is what the community wants?

Justin McCarthy – I would like to see us survey our families. We will never get all the students back in the school if we must keep 6-feet social distance. If Commissioner Riley gets his way, hybrid may no longer be an option so we need to survey our families to see if they are comfortable sending their students back into the classroom 5-days a week or if they will choose fully remote for the remainder of the school year.

Mike Fontanella – LEA has contacted us regarding the 3-feet vs. 6-feet. It will be put into motion to speak with the LEA after this meeting.

Kelly Clenchy – We all want our students to come back for in-person instruction as safe as we can. We cannot make a decision on 2-weeks of data. It is not enough. We need at least 4-6 weeks of data to make decisions. We must also see what regulation the Department of Education comes out with. We do not know that currently. We are ahead of most districts in the state. An increase of 79 more K-5 students will be in our buildings on March 1<sup>st</sup> more often than they are now. I really believe a phase in approach is the right approach

to increase the numbers of students in our buildings. I know we are doing the right thing; I do not want us not to use data and strategies to make the best decision we can to ensure we have more students in our classroom and keep our students and staff safe. Safety has to be our top priority.

Justin McCarthy – I am not suggesting that we should be back in-full by Monday. I am just not comfortable with the fact that we do not have a plan/date in place. I am suggesting that by our next meeting we can put a date on the calendar like many other districts have done.

Mike Fontanella — We have a plan in place, but we just do not have dates on the plan. I do not feel we are lacking the curve. I do not feel we should be going any faster than we are already going. I understand that if we miss a week or two weeks, there are not many weeks left of the school year. I would like to survey the families soon. We need to know if all the hybrid learners will be back in the buildings if we give them the option.

Kelly Clenchy – We can get the survey out next week. We would ask two questions – Would you be in favor to have your child in 4 days a week or have your child in school full time? We need to determine what distance we would be comfortable with.

Brad Austin – Some other district has a start date of April 26. Let us not promise things on a survey we can not back up.

Justin McCarthy – One of the questions should be "Do you want more in-person instruction and are you comfortable with less than 6-feet distance?"

- Brad Austin If we have a meeting on March 11 that would give us some more data to work with. I agree with Justin's urgency, but I cannot make a decision at this point.
- Mike Fontanella I think we should meet on March 11 instead of March 4 and then we could meet on a weekly basis moving forward.
  - Justin McCarthy If we could have a presentation of a plan in place to get more students back into the buildings at our next meeting that would be great. Have the family survey results back. It will be a lot of heavy lifting going forward. I would encourage us to speak with the LEA as well. We do not know what we need to negotiate but we know what we are surveying.
  - At what social distance would you be comfortable sending your child back into the school.
  - Kelly Clenchy Calculate the social distance in our largest classrooms in grade 1-5.

#### **Public Input:**

- Jen Gold The idea of a survey is great. I think it is important to remember that some families who are fully remote, will probably continue to stay fully remote. I would like to hear what your plans are for September and the new school year.
- Mike Fontanella From the State, any families who want to continue to stay fully remote they will be able to continue to stay fully remote. The next phase will be to have everybody back to in-person instruction.
- Sarah Belcher When you are thinking of bringing everyone back, are you thinking of outdoor learning? Mike Fontanella Yes, just like in the fall, we will be able to take that into consideration as well.
- John Krzewick One thing I have not heard is an actual goal, we need to have dates listed such as April 1, anybody that wants to be in school 5-days a week you have the right to be there. The risk is going down, I agree with the idea of the survey, but we need to set a date to be back in school full time.
- Kerry Cusick We are in a phase of vaccines. What are your plans for the teachers?
- Mike Fontanella It has been very difficult to get any data when teachers will be eligible.
- Matthew Hunt We are not hearing anything from the State or Commissioner Riley.
- Justin McCarthy Governor Baker has come out and said that teachers are the end of phase 2 and the teachers will not jump the line.
- Lynn Protasowicki Does each classroom have the air filtration system?
- Mike Fontanella Yes, each classroom has one and they have been there since December.

#### **NEW BUSINESS**

- 1. **Draft Calendar 2021/2022 School Year:** Superintendent Clenchy and Elizabeth Steele requested the School Committee to approve the calendar as presented.
- Timalyn Rassias I feel that Friday, Sept. 3 will have a large absence of students as it is just before the holiday weekend. Is there any way that the teachers could start on Tuesday, Aug. 31?
- Matthew Hunt In my district we always start before Sept. 1 and have the Friday off before Labor Day weekend, which is nice with a 4-day long weekend.

- Justin McCarthy How many half days are appropriate in a school year? It seems we have more than 16 half
   days per school.

The School needs modernization in regard to HVAC boilers and unit-ventilator systems. There is a need to have additional insulation added to the building, especially the roofing system to help prevent excessive heat on the second floor during summer months in June when the temperature in the second floor classrooms can reach in the high eighties and low ninety degrees during school hours. Studies and review of window systems need to be performed to evaluate the long term life of the window systems, and whether newer system would help with building temperatures. review and study of educational spaces would be warranted to determine optimal configurations of classroom and learning spaces to optimize learning environment and areas for all students.

7: Replacement of or addition to obsolete buildings in order to provide for a full range of programs consistent with state and approved local requirements.

Providing adequate spaces for students to meet and collaborative with staff, other students, peers, and teaching specialists will enhance their educational program and experiences allowing them to meet

district and state educational goals and program requirements. Having appropriate heating and cooling systems, modern lighting systems, and modernized learning spaces will provide students optimal learning environments where they can focus on instructional materials, programs and teaching staff;

and hereby further specifically acknowledges that by submitting this Statement of Interest Form, the Massachusetts School Building Authority in no way guarantees the acceptance or the approval of an application, the awarding of a grant or any other funding commitment from the Massachusetts School Building Authority, or commits the City/Town/Regional School District to filing an application for funding with the Massachusetts School Building Authority.

### SCHOOL YEAR/SCHOOL CALENDAR

The school calendar for the ensuing year will be prepared by the Superintendent and submitted to the School Committee for approval by May 1st of each year. The number of days or instructional hours scheduled for the school year will be determined in accordance with the following standards set by the Massachusetts Board of Education:

- 1. The School Committee shall schedule a school year which includes at least 185 days for each school in the District.
- 2. Elementary school will operate for a minimum of 180 days. Schools shall ensure that every elementary school student is scheduled to receive a minimum of 900 hours per school year of structured learning time, as defined in 603 CMR 27.02. Time which a student spends at school breakfast and lunch, passing between classes, in homeroom, at recess, in non-directed study periods, receiving school services, and participating in optional school programs shall not count toward meeting the minimum structured learning time requirement for that student.
- 3 Secondary schools will operate for a minimum of 180 days. All schools shall ensure that every secondary school student is scheduled to receive a minimum of 990 hours per school year of structured learning time, as defined in 603 CMR 27.02. Time which a student spends at school breakfast and lunch, passing between classes, in homeroom, at recess, in non-directed study periods, receiving school services, and participating in optional school programs shall not count toward meeting the minimum structured learning time requirement for that student.

For the information of staff, students, and parents, the calendar will set forth the days schools will be in session; holidays and vacation periods; in service days; and parent conferences.

### SCHOOL DAY

The length of the school day is **established in the collective bargaining agreements** with the various school unions. The specific opening and closing times of the schools, will be recommended by the Superintendent and set by the committee.

The Superintendent is authorized to make minor changes in opening and closing times to simplify transportation scheduling; however, major changes in schedules will be subject to committee approval.

Parents and guardians will be informed of the opening and closing times set by the committee. To help insure the safety of all children, parents will also be notified that students will be admitted into the school building not less than 15 minutes prior to the start of the official day unless bus schedules require earlier admittance.
